# 1. UNIF Financing

## 1.1. UNIF Bank Accounts

### 1.1.1 Account Description

UNIF has its main bank account established in the Czech Republic, in Prague branch of **VOLKSBANK LOEBAU-ZITTAU EG** located in Germany.

**Note:** The account operates in EUR in the German bank, that is why IBAN starts with DE.

Specific symbols for account transactions are 10-digit numbers from which first 3 digits describe payer and remaining max. 7 digits describe details of transaction.

## 2. UNIF Incomes

UNIF gets its incomes from

- Continental Futnet Associations (CFA)

Approved in ..... on the ..th of ....., 2020

- National Futnet Associations (NFA)
- players, referees, trainers and other involved persons
- organizers of UNIF official events
- sponsors
- other subjects

Fees paid for CFAs and for NFAs are fully in their responsibility.

## 2.1 Incomes from CFAs

Each CFA integrated in UNIF has to pay yearly contribution for its membership. The contribution does not depend on number of NFAs integrated in CFA and is ..... EUR. The CFA contribution has to be paid either to UNIF account or to UNIF treasury till ..... of the current year.

### 2.1.1 Debts of CFAs

Unpaid fees from CFAs are written in yearly Account Report. Consequences of these debts are ordered by UNIF General Assembly or – if necessary due to lack of time – by UNIF Executive Board. Fee should be paid as usual by the end of February of next year.

## 2.2 Incomes from NFAs

Each NFA integrated in UNIF and simultaneously not integrated in its CFA has to pay to UNIF according to its membership status yearly contribution either to UNIF account or to UNIF treasury till ..... of the current year.

*Full Members:*

*European countries: 500 EUR*

*Non-European countries: 400 EUR*

*Associate and Provisional Members:*

*European countries: 300 EUR*

*Non-European countries: 250 EUR*

### 2.2.1 Fees for full membership

Each UNIF-full-member NFA has to pay yearly contribution 500 EUR.

### 2.2.2 Fees for provisional membership

Each UNIF-provisional-member NFA has to pay yearly contribution 300 EUR.

### 2.2.6 Fees for associated membership

Each UNIF-associated-member NFA (i.e. observer) has to pay yearly contribution 250 EUR.

### 2.2.4 Debts of NFAs

Unpaid fees from NFAs are written in yearly Account Report. Consequences of these debts are ordered by UNIF Congress or – if necessary due to lack of time – by UNIF Executive Board.

## 2.3 Incomes from Involved Persons

### 2.3.1 Incomes from Players

Players are obliged to pay following fees:

### **2.3.2 Incomes from Trainers**

Trainers are obliged to pay following fees:

- for gaining international license after passing final exam in trainer course in amount according to organizer's calculation
- for permission to take part in UNIF World Championships in amount of ..... EUR

### **2.3.3 Incomes from Referees**

Referees are obliged to pay following fees:

- for gaining international license after passing final exam in referee course in amount according to organizer's calculation
- for permission to take part in UNIF World Championships in amount of ..... EUR

### **2.3.4 Other Involved Persons**

Other participants of UNIF official competitions have to pay special fees for permission to take part in these competitions according to their conditions.

Other persons taking part in other UNIF events have to pay special fees according to conditions of the event propositions .

## **2.4 Incomes from Organizers of UNIF events**

Organizers of any UNIF official event are obliged to pay special fee to UNIF according to agreement between them and UNIF.

## **2.5. Sponsors**

UNIF sponsors may contribute to UNIF account only under written agreement.

## **2.6 Other subjects**

UNIF welcomes all transparent contributions from maecenases, non-profit organizations, fans and other futnet-friendly persons and institutions.

## **3. UNIF Expenses**

UNIF pays following

- UNIF President necessary expenses
- UNIF Secretary General necessary expenses
- other UNIF top functionaries necessary expenses
- expenses related to UNIF official competitions
- other expenses approved by UNIF Executive Board

### **3.1 UNIF President Expenses**

UNIF covers to its President all necessary expenses related to his/her acts within official negotiations, visits and other UNIF activities.

All these expenses must be checked by UNIF auditor and approved by UNIF General Assembly.

### 3.2 UNIF Secretary General Expenses

UNIF covers to its Secretary General all necessary expenses related to his/her acts within official negotiations, visits and other UNIF activities.

All these expenses must be checked by UNIF auditor and approved by UNIF General Assembly.

### 3.3 Other UNIF Expenses of Top Functionaries

UNIF covers necessary expenses related to UNIF activities performed by UNIF top functionaries such as UNIF Executive Board members, UNIF Technical Committee Head, UNIF Treasurer, UNIF Auditor and UNIF Sport Ambassadors. All these possible expenses must be in advance approved by UNIF President and UNIF Secretary General.

### 3.4 Expenses related to UNIF Official Competitions

UNIF covers to all organizers of UNIF official competitions necessary personal and futnet expenses, such as personal rewards, futnet balls and nets, medals, winner cups etc.

#### 3.4.1 Referee Rewards

UNIF licensed referees obtain

- in World Championships min. ...EUR for being 1<sup>st</sup> referee, ... EUR for being 2<sup>nd</sup> referee and ... EUR for being table referee
- in other UNIF official competitions min. ...EUR for being 1st referee, ... EUR for being 2nd referee and ... EUR for being table referee

UNIF non-licensed referees may get 1 EUR less for each referee's position.

#### 3.4.2 Rewards for Technical Committee

UNIF Technical Committee members (supervisors, competition leaders etc.) can obtain reward according to number of playing days, i.e. ... EUR per a day.

#### 3.4.3 Rewards for Organizers

Organizers of UNIF official competitions has to get min. 2 balls and 1 net for each court used in competition, 2 balls and 1 net for final stage, cups for winners in all categories and disciplines and sets of gold, silver and bronze medals containing medals for all players incl. substitutes, 1 coach and 1 for NFA or club.

## 4. Financial Reports

All incomes and expenses must be written in yearly Financial Report enclosed with bank account report issued on 1<sup>st</sup> of January and 31<sup>st</sup> of December.

The report must be approved and signed by UNIF auditor and then approved or not by UNIF General Assembly.

## 5. Final Provisions

These regulations are valid immediately after approval of UNIF General Assembly.

Official explanation of all paragraphs of these regulations belongs only to UNIF Executive Board.
